- II. **PRAYERS:** The Clerk, **Mr. Ibrahim S. Sesay**, said the prayer.
- III. **SUSPENSION OF STANDING ORDER 5(2) AT 10: 45 A.M.**
Hon. Songowa Bundu (Const. 061 – Tonkolili Dist.) moved the suspension of Standing Order 5(2). It was seconded By **Hon. Sulaiman Muluku Sisay (Const. 033 -Bombali Dist.)** , and unanimously approved by the House.

- VI. **STATEMENT BY MR. SPEAKER**
Mr. Speaker appealed most honourably to Members to keep to the traditional time for the commencement of parliamentary sittings. He also urged Honourable Members to be responsible and punctual at all times. He further raised concern over the recess of Parliament, as he said *“Parliament did not go on recess simply because they could not”* .
- VII. **Announcement by the Majority Leader and Leader of Government Business, Hon. Leonard S. Fofanah**
The Majority Leader of the House informed Hon. Members that there would be a very important meeting on Thursday, 14th September. 2017, at 11:00 a.m. in Committee Room number one. The Majority Leader requested that all Members must attend with a copy of

the Bill entitled: The Food and Feed Safety Authority Act, 2017, and that all stakeholders that are party to the bill are invited.

VIII. STANDING ORDER 23 (PERSONAL EXPLANATION)

Hon. Ansumana J. Kaikai (Deputy Minority Leader) – Raised concern over lateness for parliamentary deliberations. Recalling that when he was a Chief Whip in the House, he was always conscious of time, he urged Members to keep to the stipulated time of 10:00 a.m.

Hon. Dr. Bernadette Lahai (Minority Leader) – Informed Members about a study tour she made to Brussels at the European Parliament with a delegation consisting of the Chief Whip of the Parliament of Sierra Leone, the Vice president of the Pan African Parliament (PAP) including a cross section of Members of PAP from the 4th to 6th September, 2017. During the visit, they paid a courtesy call on the Embassy of Sierra Leone accredited to the European Union as one of the major donors for the development of Sierra Leone. They were warmly received by His Excellency, Hon. Ibrahim Sorie and staff. They held a serious meeting with regards the operations, status and challenges of the embassy. The following were highlighted:

- i. Issue regarding Sierra Leone's representation on the various committees – that there are only two staff at the embassy which are the Head of Chancery and his Deputy, and they are required to sit in the various committees and sometimes the meetings are held simultaneously. The same shortage of staff for the UNESCO desk in Paris.
- ii. The Hon. Members also highlighted the issue of subvention previously remitted every three months, but now being remitted every six months resulting in overdrafts with huge interest.
- iii. Last but not the least; the Hon. Member disclosed the issue of migration with regards to persons without proper documents within Brussels and surrounding countries, noting that Sierra Leone should abide by the Vienna Convention of diplomacy to reduce the risk of the Embassy being closed.

She called on the Immigration Department, Ministry of Internal Affairs, Ministry of Foreign Affairs and various parliamentary committees concerned, to look into the matter.

Hon. Kerifala S. Conteh – Raised concern over the NATCOM mandate on free calls. The Hon. Member reported that the telecom networks were all almost down to zero during the weekend. As promised, the telecom providers “were to give” six hours free calls to their subscribers, which they miserably failed to do. The Hon. Member called on the Parliamentary Committee on Information and Communication to find a new punishment for telecom providers and said that they should rather compensate their subscribers.

Hon. Ibrahim Ben Kargbo - With regards the concerns raised by **Hon. Kerifala S. Conteh**,

Hon. Ibrahim Ben Kargbo said he witnessed the meeting in which fines were levied on telecom providers in the form of free calls for failing to fulfill their obligations towards their subscribers. In view of this, the Hon. Member concluded that an oversight would be conducted the following week.

Hon. Jusufu B. Mansaray – Raised concern over the meeting on the Food Safety Bill, that since the S.L.P.P Members would be on their party convention on Thursday, 14th September, 2017, he was kindly requesting that the Leadership of Parliament reschedule another date for the meeting on the Bill so that all Members would have equal opportunity to make their own contributions

Hon. Sulaiman Muluku Sisay – Commented on the Kenyan elections as he was an A.U. representative to observe a free and fair election. The Hon. Member said they had a pre-elections briefing before the elections, where he suggested that the problems engulfed the two families of the presidential candidates i.e. the Kenyatta and the Odinga, which was proven to be true. The election went well because there was reconciliation before the event. He advised that Sierra Leone should do the same to prevent violence during our own election period.
