The Appropriation Act, 1998

Short title.

Being an Act to provide for the Service of Sierra Leone for the year 1998.

[17th February, 1998] Date of Commencement.

WHEREAS it is necessary to make provision for the issue from the Consolidated Fund of sums of money to meet the expenditure to carry on the services of the Government:

NOW, THEREFORE, be it enacted by the President and Members of Parliament in this present Parliament assembled.

Commence-
ment.

1. This Act shall be deemed to have come into operation on the 17th day of February, 1998.

Interpretation.

Act No. 1
of 1992.

2. For the purposes of this Act and notwithstanding the provisions of Section 2 of the Public Budgeting and Accounting Act, 1992, "fiscal year" means the period extending from the 17th day of February, 1998 to the 31st day of December, 1998.

3. The sum of one hundred and sixty-two billion, four hundred and twenty million, seven hundred and eighty-two thousand, seventy-two leones shall be and is hereby granted to His Excellency the President for and during the fiscal year and the same shall be applied and expended in the manner herein described and for the several services set forth in the Schedule.

4. The sum of one hundred and sixty-two billion, four hundred and twenty million, seven hundred and eighty-two thousand, seventy-two leones referred to in section 3, shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Fund for the fiscal year and the payment thereof shall be taken to begin and commence on and immediately after the seventeenth day of February, Nineteen Hundred and Ninety-eight.

Accountant-

5. The Accountant-General is hereby authorised and required to pay out of the Consolidated Fund for the several services specified in the Schedule, such sums as may be specified in the Warrant or Order of the Minister of Finance, Development and Economic Planning issued from time to time up to the total sum of one hundred and sixty-two billion, four hundred and twenty million, seven hundred and eighty-two thousand, seventy-two leones which shall come in course of payment during the fiscal year.

Excess of
expenditure.

6. The amount from time to time paid for and in respect of the expenditure authorised in section 5 shall not exceed in the gross the sum of one hundred and sixty-two billion, four hundred and twenty million, seven hundred and eighty-two thousand, seventy-two leones from the seventeenth day of February, Nineteen Hundred and Ninety-eight inclusive, and any balances remaining unissued at the end of December, Nineteen Hundred and Ninety-eight shall lapse and not be available for making any payment in the following year.
