**HON. CHERNOR R.M. BAH** – Read out the above Standing Order.( S.O.75): He informed the House that he received the Seventh Report of the Committee on Appointments and the Public Service, which was a premature publication in the morning of Wednesday, 27<sup>th</sup> June, 2018, purportedly done by the Committee Clerk assigned to the Committee on Appointments and the Public Service. Considering the subject for debate, the Hon. Member confirmed to the House that the report was Premature by virtue of the aforesaid S.O., and that its content was contrary to the outcome of the Committee meeting which was not unanimous as stated. The Leader of the Opposition “kindly” requested that the “**Motion of the Committee on Appointments and the Public Service**” be expunged from the Order Paper. The reason being the House could not discuss a subject which had not yet been concluded by the committee. The Leader of the Opposition informed the House that the report bore his name but the content was incorrect. The Committee he said was scheduled to meet at 10:00 a.m. on Wednesday, 27<sup>th</sup> June, 2018, to conclude their decision in order for it to be submitted to the House. But unfortunately the meeting was not held.

**HON. DR. KOLLEH KANDEH YUMKELLA** – The Hon. Member further clarified the matter to the House. He revealed that they are yet to conclude their work and have not made any decision to be presented to the House for a resolution. He advised the House to adhere to the rules of procedure. Secondly, the Hon. Member commented on the report that was done by the Parliamentary Public
