### A BILL ENTITLED

**The Supplementary Appropriation Act, 2025**

Short title.

Being an Act to make revisions and supplementary provision  
for the services of Sierra Leone for the year 2025

WHEREAS by the Appropriation Act, 2025 a sum not exceeding twenty seven billion seven hundred and sixteen million three hundred and fifty seven thousand four hundred Leones was provided for the services of Sierra Leone for the year two thousand and twenty five;

WHEREAS it has become necessary to revised the expenditure downwards from the Consolidated Fund, a reduced sum of eight hundred and seventy one million eight hundred and thirty seven thousand two hundred Leones less of the provision in the Appropriation Act, 2025;

AND WHEREAS subsection (3) of section 112 of the 1991 Constitution states that where in respect of any financial year, it is found that the amount of moneys appropriated by the Appropriation Act for any purpose is insufficient or that a need has arisen for expenditure for a purpose for which no amount of moneys has been appropriated by the Act, a supplementary estimate showing the sum of money required shall be laid before Parliament;

AND WHEREAS section 42 (1) (a) to (e) of Public Financial Management Act 2016 provides that a supplementary estimate under paragraph (b) (ii) of sub section (3) of section 111 of the Constitution shall be submitted to Parliament subject to subsection (3) of section 112 of the Constitution and shall be appropriated by a Supplementary Appropriation Act under subsection (4) of section 112 of the Constitution;

AND WHEREAS sub-regulation (1) of Regulation 25 of the Public Financial Management Regulations 2018 provides that: a supplementary estimate shall not increase the total expenditure of the State budget, unless the increase in the total expenditure-

- (a) is required due to a natural disaster, epidemic of illness, or other significant and unforeseen economic and financial event;
- (b) can be financed by the increase in the revenue other than domestic or external borrowing

AND WHEREAS sub-regulation (2) of Regulation 25 of the Public Financial Management Regulations 2018 provides that supplementary estimate shall be accompanied by a justification for its proposal;

NOW, THEREFORE, be it enacted by the Members of Parliament in this present Parliament assembled, as follows:-

1. This Act shall be deemed to have come into operation on ~~Commencement~~ the 1st day of July, 2025.

2. The sum of fourteen billion four hundred and sixty one NLe14,461,760,400 million seven hundred and sixty thousand four hundred Leones shall ~~revised estimate~~ be and is hereby granted to the President, for and during the period July to December 2025 set forth in the First Schedule.

3. (1) The sum of fourteen billion four hundred and sixty one NLe14,461,760,400 million seven hundred and sixty thousand four hundred Leones ~~charged on revenue~~ shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Fund for the period July to December 2025 and the payment shall be taken to begin immediately after the commencement of this Act.

(2) Payment of the sums authorized by the Minister responsible for Finance to be issued from the Consolidated Fund shall be taken to have begun on the date of the warrant authorizing such payment.

4. The Accountant General is hereby authorized and required from time to time upon warrant or order of the Minister responsible for Finance to pay out of the Consolidated Fund - Accountant General's authority for payment.

(a) the sum of fourteen billion four hundred and sixty one million seven hundred and sixty thousand four hundred Leones for the services specified in the First Schedule;

Excess of expenditure

5. The amount from time to time paid for and in respect of expenditure authorized in section 2 shall not exceed the fourteen billion four hundred and sixty one million seven hundred and sixty thousand four hundred Leones from the 1st day of July, 2025 and any balances remaining unissued at the end of December, 2025 shall lapse and shall not be available from making any payment in the following year.
