Standing Order 7 (1) (Quorum):

The Deputy Clerk of Parliament, **Mr. Gilbert Bosco N'habay**, made the following pronouncement as quoted: **"Mr. Speaker, Hon. Members. Pursuant to Standing Order 7(1), this House has formed a quorum to commence its proceedings."**

1. Prayers were read by Miss. Isha M. Koroma (Table Clerk)

2. Suspension of Standing Order 5 (2) at 10: 05 a.m.

The motion for the suspension of S. O. 5 (2) at 10:05 a.m. was moved by **Hon. Dickson Momoh Rogers from Pujehun District** for the commencement of proceedings. The motion was seconded by **Hon. Musa Fofanah from Kono District** and approved by the house.

3. Amendment of Order Paper:

The Leader of Government Business and Majority Leader of the House, **Hon. Mathew Sahr Nyuma from Kenema District** moved a motion to amend the Order Paper by replacing the Substantive Chairman of the Public Accounts Committee (**Hon. 5. Mr. Speaker's Announcement:

The Speaker, **Hon. Ibrahim Tawa Conteh**, informed the House about the issue between the Parliamentary Committee on Trade and Accord Logistics. Pursuant to Section 93 of the Constitution of Sierra Leone 1991 (Act No. 6 of 1991), he reminded the House about the mandate of every Parliamentary committee to conduct oversight, and that the oversight must also bring forth reports to the House as recommendations.

6. Laying of Papers:

- A. The Table Clerk, **Ms. Isha M. Koroma**, called upon the Deputy Chairman of the Public Accounts Committee (**Hon. P.C. Desmond M. Kargobai**) to lay the papers that were itemized on the Order Paper.

The Deputy Chairman of the Public Accounts Committee (**Hon. P.C. Desmond M. Kargobai**) laid the following papers:

- (i.) **Report of the Public Accounts Committee (PAC) on the Consideration of the Report of the Auditor-General on Local Councils for the Financial Year 2003.**
- (ii.) **Report of the Public Accounts Committee (PAC) on the Consideration of the Report of the Auditor-General on the Accounts of Sierra Leone for the Financial Year 2023.**

Mr. Speaker's Announcement:

Mr. Speaker reminded the House that even though he was the presiding officer for that day's sitting, he was also Deputy Speaker and Chairman of the Public Accounts Committee as provided for by the Standing Orders of Parliament. Pursuant to Standing Order 25 (Notice of Motion), he noted that the work of the Public Accounts Committee was the hard-won ethos of that Parliament. He informed the House that the Public Accounts Committee during the consideration of the 2023 Auditor-General's Report was able to recover NLE 24, 025,499.86 from MDAs, and that the PAC was also

able to do the deduction and settlement of outstanding royalties of \$760,000 owed by Zoodlab to the Government of Sierra Leone. He noted that the Committee was able to resolve 60% of the issues raised by the 2023 Auditor-General's Report on the accounts of MDAs and 42% of fully resolved issues on the accounts of councils. He further noted that the PAC together with NRA was able to recover NLe13.5 million. Mr. Speaker acknowledged the presence of some children from Gate Way International School who were in the chamber to witness the proceedings of Parliament.

- B. The Table Clerk, **Ms. Isha M. Koroma**, called upon the Deputy Leader I of Government Business and Head of Pan-African Parliament Delegation **Hon. Bashiru Silikie from Bo District** to lay the papers that were itemized on the Order Paper.
