Statement by the Chairman of the Appointments Committee:

The Chairman of the Appointment Committee as well as the Majority Leader and Leader of Government Business (**Hon. Mathew S. Nyuma**) read out the letter of Appointment of the Chief Electoral Commissioner from the Office of the President, State House as mandated in Section 32 (3) of the 1991 Constitution of Sierra Leone. He recited the said provision as quoted: **"The members of the Electoral Commission shall be appointed by the President after consultation with the leaders of all registered political parties and subject to the approval of Parliament."** He stated that sixteen registered political parties were copied of the said letter of Appointment with the exception of C4C as a result of injunction. In view of the phrase: **"After consultation with the leaders of all registered political parties ...,"** he informed the House that the Chairman of the Political Parties Regulatory Commission (PPRC) stated that out of seventeen registered political parties nationwide, thirteen political parties (**The National Democratic Alliance – NDA; The Alliance Democratic Party – ADP; The National Grand Coalition – NGC; The Sierra**

Leone People's Party – SLPP; The United National People's Party – UNPP; The People's Democratic Party – PDP; The Peace and Liberation Party – PLP; The Citizens Democratic Party – CDP; The Revolutionary United Front Party – RUF; The People's Movement for Democratic Change – PMDC; The United Democratic Movement – UDM; The Republic National Independent Party – ReNIP and The National Unity and Reconciliation Party – NURP) approved via consultation the nomination of **Mr. Edmond Sylvester Alpha** as Chief Electoral Commissioner while two parties (**The All People's Congress – APC and the Unity Party – U P**) did not approve his nomination; and two other parties (**The Coalition for Change – C4C and The National Progressive Democrats – NPD**) did abstain from the said process. In lieu of his submission, he informed the House about the details of all registered political parties in Sierra Leone as furnished by the Political Parties Regulatory Commission (PPRC) as follows:

APC; SLPP; PMDC; NDA; PLP; RUF; UDM; CDP; UNPP; PDP; ADP; NPD; NGC; UP; C4C; NURP and ReNIP. For the edification of the House, he thereby tendered all of the said documents to the Clerk of Parliament for his onward submission to Mr. Speaker.
