Standing Order 7 (1) (Quorum):

The Clerk of Parliament, **Mr. Karmoh K. Conteh**, made the following pronouncement as quoted: **"Mr. Speaker, Hon. Members. Pursuant to Standing Order 7(1), this House has formed a quorum to commence its proceedings."**

1. Prayers were read by Ms. Yeama Mamie Musa (Table Clerk)

2. Adoption of the Record of Votes and Proceeding for Thursday 26th March 2026:

The motion for the adoption of the record of votes and proceedings for Thursday 26th March, 2026 was moved by **Hon. Joseph Williams-Lamin** from **Bo District**. It was seconded by **Hon. Idriss Sahid Kamara** from **Western Urban District** and adopted by the House as amended.

3. Mr. Speaker's Announcement:

The Speaker (**Hon. Ibrahim Tawa Conteh**) informed that his announcement was to continue to enlighten and educate the public that the quorum of Parliament was $\frac{1}{4}$ of Members present. He noted that Section 89 of the Constitution of Sierra Leone (Act No. 6 of 1991) does not require a combination of partisan equation. Hence, $\frac{1}{4}$ of the Membership of Parliament were present in the Chamber, the Business of Parliament shall continue, and that was constitutional. He reminded the public about Section 94 (1) of the Constitution that gives Parliament the power and right to regulate itself. He also stated that Section 94 (3) of the Constitution re-echoed the provision of Section 89 by stating that a vacancy in the Chamber caused by any of the reasons whether by absenteeism, boycott etc. will not invalidate the proceedings or decisions of the House. He noted that as Members of Parliament continue to do the Business of the people as stated in Section 97 of the Constitution, he encouraged the Majority Leader and Leader of Government Business to ensure that the business of the state should continue to come to the House. He reminded Parliamentary Sessional Select Committees about the availability of quorum and noted that in the case of Committee meetings, **paragraph 4 of Standing Order 73** applies.

He thereby called upon the Clerk of Parliament to make announcement in accordance with **Standing Orders 72(2) and 73 (2)**.

Mr. Speaker acknowledged Members of Parliament for their prompt and punctual attendance to commence the Business of the House. He encouraged all of them to continue doing the good work for the people of Sierra Leone.

Mr. Clerk's Announcement:

The Clerk of Parliament (**Mr. Karmoh K. Conteh**) informed the House about a notice of meeting that was served on his office from the Parliamentary Committee on Human Rights by the following Members: **Hon. Brima Mansaray; Hon. Nenneh Lebbie; Hon. Mariama M. Zombo; Hon. Amie N. Moriba; Hon. Rugiatu Tarawally-Musaffa; Hon. Fatmata Sarah Soukenah; Hon. Hindolo Moiwo Gevao and Hon. Osman Wurie Jalloh**. He noted that the Chairman of the said Committee was **Hon. Dr. Unpha S. G. Koroma** from the Opposition, but in his absence, the aforementioned Members of the Committee had made request to hold a meeting on Wednesday 1st April, 2026 in the New Administrative Building of Parliament at 10 am prompt.

For the edification of the House, Mr. Clerk read out Standing Order 73 (2) as quoted: **"Save where it is otherwise provided in any Order, if the Chairman is unable to be present at any meeting, the Committee shall elect another Chairman whose tenure of office shall be for the day of his election."**

Mr. Speaker's Ruling:

The Speaker (**Hon. Ibrahim Tawa Conteh**) ruled that the notice of meeting as proposed by the Members was granted.

4. Government motion by The Minister of Finance:

The Table Clerk, **Ms. Yeama Mamie Musa**, called upon The Minister of Finance to proceed with the Government Motion.

The Minister of Finance (**Mr. Sheku Fantamadi Bangura**) presented the object and reasons of the Government motion to the House and moved as thus:
