Mustapha Musa Sellu from **Moyamba District** rose on S.O. 23 and reminded **the House** about an in-fight between two neighbouring communities in his District that resulted to the death of one man whom had already been buried. He informed the House that the burial ceremony was supported by the Sierra Leone Police, while he applauded and appreciated the intervention by the **Inspector General of Police (IGP)**. He also noted that the tension between those two communities was still rising and that required a much stronger intervention. He craved the indulgence of Mr. Speaker for his continued supports to put the said issue to rest.

Mr. Speaker responded by directing the Hon. Member to again meet with the Chairman of Internal Affairs to further engage the **Inspector General of Police** to see how best they could finally bring that matter to an end.

II. Hon. Charles Osman Abdulai from **Bo District** rose on S.O. 23 and reminded the House about his earlier submission concerning an issue between him and the former IGP (**Ambrose Michael Sovula**), upon which all the needful (**Formal complaint**) had been complied with and submitted to the Parliamentary Committee on Ethics for investigations. He noted that since then nothing had been done by the said Committee in relation to the issue.

Mr. Speaker, thereby, directed the Chairman of the Parliamentary Committee on Ethics to see him in his chambers immediately after sitting.
