X. STANDING ORDER 23 (S.O.23):

The following Honourable Members stood on Standing Order 23 (S.O. 23) -

1. **Hon. Mabinty Funna** - That on 30th December, 2012, Hon. Dr. Bernadette Lahai received an award for best Parliamentarian of the year, showing that women have the ability for leadership.
2. **Hon. Benneh Bangura** - That on 4th January, 2013, a village in his constituency, Robenk, N was engulfed by fire disaster, leaving over three hundred people homeless; but he thanked the African Minerals who helped immensely to save the lives of the people with assistance given to them. He appealed to Members of Parliament to render help, including Non-Governmental Organisations(NGO's) and other institutions.
3. **Hon. Edward S. Jengo** - Out of Order (Controversial).
4. **Hon. Jusufu B. Mansaray** - Made an appeal to the Majority Leader, Hon. S.B.B. Dumbuya for expeditious attention to past Members of Parliament who have not yet received their gratuities.
