Member called on Parliament to enact laws that will hold companies producing plastic products to be responsible and induce recycling of plastic items to prevent perilous incidents that will create a negative impact on the lives of Sierra Leoneans as well as the environment.

Hon. Bashiru Silikie – Requested that the Leadership of Parliament summon the Minister of Finance, to explain the successes and challenges of the Finance Act 2017, which was passed in Parliament three months ago.

Hon. Foday Rado Yokie – Raised concern over the welfare of parliamentarians, that they are Public Servants and must be entitled to every benefit as an employee. The Hon. Member specifically mentioned the entitlement of Members to a recess when it is due with a leave allowance.
