THE APPROPRIATION ACT, 2013

Being an Act to authorize expenditure from the Consolidated Fund for the services of Sierra Leone for the year 2013

A. INTRODUCTION AND FIRST READING

The Minister of Finance and Economic Development

The Minister of Finance and Economic Development, Dr. Kaifala Marah read the Budget Speech for 2013, and moved that the Bill be read the first time.

The Bill was read the first time and was unanimously accepted by Members of Parliament.

VI. GOVERNMENT MOTION:

The Minister of Finance and Economic Development

Be it Resolved:

That pursuant to Section 113 of the Constitution of Sierra Leone (Act No. 6 of 1991) this Honourable House authorize the Minister of Finance and Economic Development to withdraw monies from the Consolidated Fund for the purpose of meeting expenditure necessary to carry on the services of the Government and approve the expenditure of the sum of Le 831,373,433,333 for the period expiring four months from the beginning of the Financial year 1st January, 2013 or the coming into operation of the Appropriation Act of 2013, whichever is earlier.

The Minister of Finance and Economic Development read the motion to Members of Parliament and explained the objects and reasons.

The following Honourable Member contributed to the debate on the motion.

The motion was unanimously carried.
