**III. AMENDMENT OF ORDER PAPER:**

**Item Vii – Formation of the Committee of Selection – S.O. 70(1)** was deleted from the Order Paper.

**IV. PROCEDURE FOR TAKING OF AN OATH BY MEMBERS OF PARLIAMENT:**

Mr. Clerk briefed Members of Parliament on the procedure for the swearing-in of elected Members.

The swearing-in was done in groups of twelve, administered by the Clerk of Parliament and his Deputy.

Members of Parliament took and subscribed to the oath of office, pursuant to the Third Schedule of the 1991 Constitution, Act No. 6.

**V. ELECTION OF THE SPEAKER OF PARLIAMENT SECTION 79 OF THE CONSTITUTION OF SIERRA LEONE (ACT NO. 6 OF 1991) AND STANDING ORDER 8:**

**A. NOMINATION:**

Hon.S.B.B.Dumbuya of Constituency 100, in the Western Area Urban nominated Hon.Justice Abel Nathaniel Bankole Stronge. He was seconded by Hon.Dr. Bernadette Lahai of Constituency 13, Kenema District.

**B. CLOSURE OF NOMINATIONS:**

In the absence of any other nomination, Hon.Komba Eric Koedoyoma moved for the closure of Nomination.He was seconded by Hon.Andrew Victor Lungay.

**C. DECLARATION BY THE CLERK OF PARLIAMENT:**

The Clerk of Parliament declared Hon.Justice Abel Nathaniel Bankole Stronge as duly elected Speaker of the Fourth Parliament of the Second Republic pursuant to Standing Order (S.O) 8(3) which reads as follows:

If only one person is so proposed, the Clerk shall propose the question that that person do take the chair of the House as Speaker.

Hon.Komba Eric Koedoyoma of Constituency 27, Kono District, nominated Hon.Chernor R.M. Bah for the position of Deputy Speaker. He was seconded by Hon.Ibrahim R. Bundu of Constituency 52, Port Loko District, in the presence of the Speaker of Parliament.
