In the light of the foregoing,the Chairman thought it wise to suspend further reading of the Report in order to give the Chairman of the Appropriation Sub-Committee (1), adequate time to make appropriate amendments.

In the same vein, Hon. Sheku B.B. Dumbuya, Majority Party Leader and Head of Government Business disclosed with the leave of Mr. Speaker that, the business of the House is behind schedule and the Majority Leader further informed Members that next week Tuesday 15th and Friday 18th February, 2011 respectively, are likely to be Public Holidays.

However, the Speaker decided to adjourn the House in order to give the Chairman of Sub-Committee (1) adequate time to re-adjust his report, despite the pending Holidays.
