The following amendments were made at the Committee Stage:

1. **PART 1: Preliminary:**

**Section 1a(ii):** to remove the word “anal” after the words “genital or”

**Section 1c:** under “Person with mental disability” to add “Physical” to read thus:  
“Person with mental and physical disability”.

2. **PART 2: Sexual Offences Generally:**

**Section 6:** to remove “not exceeding fifteen years” and add after “imprisonment”  
“not less than 5 years and not exceeding fifteen years”.

**Section 8 (1):** to add after the word “imprisonment” “not less than 5 years and not  
Exceeding 15 years”.

**Section 9 (1):** to add after the word “imprisonment” “not less than 5 years and not  
Exceeding 15 years”.

**This applies all through sections containing the imprisonment term.**

**Section 9 (3)a:** to add after the words “or has functions” after the word “is employed...”

**Section 22:** to add “intentionally” after the word “who”.

**Section 25(2)g:** to add “traditional healers” after the word “professional”.

**Section 27(b):** to remove the word “knowingly”.

**Section 38(1)a:** to add “and establishes a case for the victim and the victim may not  
Withdraw without good cause”

**38(1)c:** to add “and report” after the word “mental” and also correct the word  
“whether” to “whenever”.

**38(2):** to add the phrase “and obtained a medical report” after the word  
“facility”.

**THIRD READING AND PASSAGE INTO LAW:**

The Bill was read the third time and passed into law.
