STANDING ORDER (S.O. 23)

The following Honourable Members stood under S.O 23

1. Hon.Elizabeth Alpha-Lavallie - Presented a hand book for Parliamentarians entitled “ Taking Action Against HIV/AIDS” sponsored by Inter-Parliamentary Union(IPU) Advisory Office.And also informed Members that Hon.Dr Brima M.Kamanda is a member of the West African HIV/AIDS Committee;
2. Hon.Augustine B.Torto - Informed the House about the deplorable state of the Matotoka/Kono road.He called on Members of Parliament and the Minister of Works to look into the matter;
3. Hon.Mathew S.Nyuma - Submission to Finance Committee that the salary grades of the Parliamentary Service Commission Staff are not the same as compared to other Commission.
4. Hon.Eric B.Jumu - That the Electricity Act 2012, almost desolved the National Power Authority(NPA) and that of Bo/Kenema Power Station(BKPS) Boards;
5. Hon.P.C.Jeremiah Sinnah-Yovonie Kangova II - That motor bike riders are causing a lot of traffic obstructions;

6. Hon.Ibrahim Sorie - That Okada riders are becoming uncontrollable, not obeying traffic laws, and danger to the Public.He called on the Minister of Transport and Aviation and Internal Affairs to look into the matter.

Secondly, he stated that the access road to Parliament is not convenient for Members of Parliament due to obstructions from Motor bike riders and School going children.He noted that the dust bin at Government Model School junction should be removed. That the Minister of Works must be invited including the Inspector-General of Police.
